Food Security is one (1) of the eleven (11) Global Clusters for Humanitarian response; Covid-19 highlighted the importance of this sector worldwide and ADRA Bahamas sought to provide aid to persons throughout **all** five (5) constituencies of **Grand Bahama**.



On Tuesday October 26th, ADRA Bahamas hosted a Hydroponic System Training Workshop, which was facilitated by Mr. Jermaine Turnquest of Grow Life Supplies at a Community Centre whose use was entirely donated by Mr. Darryn Rolle, Director of the Falcon Boys Club (Grand Bahama) to ADRA Bahamas.

Through an engaging session, the farmers learned about the systems, their operation modes,

pruning techniques, substrates and how to blend them to obtain higher yields, proper maintenance and the fact that it is a self-watering system that can accommodate the growth of multiple numbers of 1 crop simultaneously- "organically" (use of no chemicals to aid in growth-fertiliser & soil) or "unorganically" (without soil but nutrients are placed in the water).
